Violation #51. Plumbing installed; proper backflow devices

- Hot water handle missing at mop sink.

CODE REFERENCE: 64E-11.003(5)(c). Plumbing will be installed and maintained to comply with plumbing requirements, including backflow prevention devices. A mop sink will be provided.

Violation #54. Garbage & refuse disposal

- Dumpster plug missing.

- Garbage on floor behind dumpster.

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

NOTE: Broccoli 148F; mashed potatoes 155F; Delfield 39F; Delfield 2 door 41F; Pepsi True 29F; True counter cooler 40F; milk 38F; quaternary ammonium 400ppm/101F; hot water greater than 100F throughout.

NOTE: Training: CFM conducted training, a DBPR Approved Food Safety Program - conducted 8/8/18

NOTE: With rainy season approaching, please note that the dumpster area requires proper drainage. This area regularly floods with rain making it difficult to access when the area is under water. The code requires this area be sloped to a drain.
